McKesson believes that transparency and accountability with respect to political expenditures are important. U.S. law prohibits companies from contributing to candidates for federal office, but many states allow corporate contributions to state and local candidates, parties, committees, ballot measures, and political organizations. While the McKesson Employees' PAC is the primary vehicle for political engagement, the company does make a limited number of corporate political contributions at the state level where permitted by law. McKesson made the following contributions during calendar year 2016 and calendar year 2017 as permitted by U.S. and state law and subject to any legal limitations and applicable reporting requirements. This list also includes payments to entities organized under § 527 of the Internal Revenue Code (also known as "527 organizations"). This report is regularly updated when new contributions are made.
