Advances Manageability

Point of Sale provides the information you need to manage your pharmacy business with greater success. Management reports provide insights that help you effectively control merchandise movement, pricing, inventory, Accounts Receivable, prescription sales, cashier/store productivity, and cashier accountability.

The Windows-based registers store configuration, inventory, and transaction information locally, allowing registers to continue operating during a network or server failure. When connectivity is restored, the system automatically synchronizes.

EnterpriseRx Integration

Cashiers can perform a real-time prescription lookup with EnterpriseRx for each prescription sold in the transaction, verifying the prescription is available for sale. When the prescription is sold, POS updates EnterpriseRx with the status.

As the transaction is completed, the patient can select to charge the sale to their AR account. POS also supports an AR Account search facility and can charge to either the Primary or Member account holder, while sending item-level details for the transaction back to AR. In finalizing the AR charge, POS captures an eSignature for the payment and then also requests a privacy signature (if required) as well as the appropriate prescription related signatures (pick-up, counselling, safety-cap, etc).
