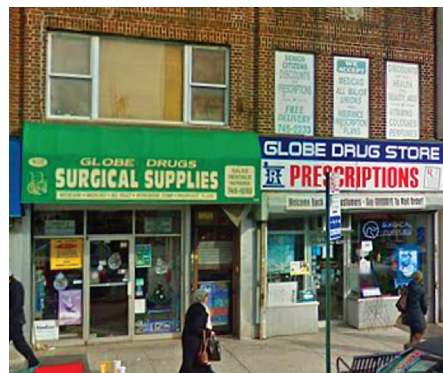

Brett shared his enthusiasm for the PharmacyRx system while at McKesson's ideaShare 2017. "The big advantage that PharmacyRx has is that it's easily customizable. The code is very stable and it doesn't take much to add new features and functionality. This means you can get new releases ready very quickly."

Brett further explained why he prefers PharmacyRx. The system gives him everything he needs to fill a prescription quickly and efficiently. "PharmacyRx is awesome," he said. "If I need to send a prescription to a doctor, I just press a button and PharmacyRx sends it automatically for me."

System Flexibility and Reliability.

Brett is pleased with the flexibility and stability of the PharmacyRx system, and spoke about being an advocate of the application for many years. He talked about the configurability of the system, the power and speed of the application, and its reporting capabilities. "It has almost every kind of report I need," he said. "If it doesn't have a certain report, I go to the Advisory Board, and we get one in there."

When recommending PharmacyRx to new users, Brett commented, "Everyone that sees me demonstrate this product loves it!" Discussing the variety of

customizations available in PharmacyRx, he said, “Little things come up as technology changes. As pharmacy rules change, there are always new things to be concerned about. PharmacyRx is so adaptive to our needs.”

Asked for details, Brett provided an example. “I attended a PharmacyRx board meeting recently, and two customers from two different states needed a small change to be made. Eventually, this small change will impact customers in all states. The board discussed it, and a month or two later, the change was implemented in the next PharmacyRx release.”

Customer Service and Implementation

Addressing other benefits of PharmacyRx over several days at the ideaShare show, Brett noted, “McKesson Pharmacy Systems’ Customer Support is excellent. I’ve always gotten what I needed in a timely and courteous manner from Support.”

Regarding the implementations process for new users, Brett responded, “The PharmacyRx implementation process is fantastic. It usually takes 2 to 2½ days. I recently helped a friend of mine switch over to PharmacyRx in his store, and Denise was phenomenal. She trained two staff members and I helped train one. Everything went very smoothly.”

Reaching Out to Patients in New Ways

Using PharmacyRx helps Brett distinguish his store from the big box chains. “Using PharmacyRx lets us provide a more personalized approach,” he said. “We are more likely to have the same pharmacist



and staff members over a long time, who know the patients and understand their issues. PharmacyRx has central fill functionality, it has its own MTM module, and now has a med sync feature integrated right within the system. These types of features help us enhance our service levels even more.”

When asked about potential new programs, Brett noted how fast his compounding business is growing. He also focused on the medication synchronization (med sync) features integrated into Pharmaserv release 7.6. “The biggest challenges for community pharmacies today revolve around trying to take care of patients the best we can,” given the myriad of limitations and changing rules. “PharmacyRx does so many things to help me provide better service and better health outcomes. I really would not consider any other system.”
