#### Return more unsaleable products, earn more credit

MRRS accepts unsaleable:

- Rx Drugs
- Controlled drugs, including Class II-V
- AbbVie PPD
- Nonhazardous drugs
- OTC and HBC products, including Sunmark<sup>™</sup> private label
- "Wholesaler only" products some manufacturers don't accept as returns
- Recalled drugs

MRRS will only issue credit on eligible products based on manufacturer policy

#### How it works

With MRRS, intended for McKesson-purchased items only, you send one no-cost shipment to one processor. The credit you earn is applied to your McKesson account 30 days after your return is processed, reducing your overall costs and improving your bottom line.

#### It's easy.

Here's how MRRS takes the hassle out of returning unsalable products.

- 1. Access the free online returns processing tool.
- 2. Scan or key in each unsalable item, "close the box," print the shipping labels, and post an online pickup request for the carrier.
- 3. Put Rx and OTC products in one box and any Clls should be boxed separately.
- 4. Seal the boxes and apply the printed shipping labels. Hand the boxes to the carrier.
- 5. Check your McKesson account for credit 30 days after box processing date.
